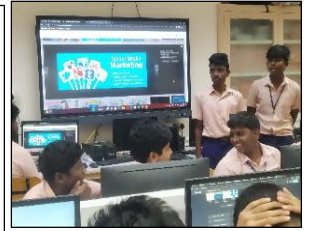
We are honoured to bestow on him Distinguished Alumnus award on the Alumni day, 15<sup>th</sup> October 2023.

Computer education is not a part of the state board syllabus for 6th to 10th students. However, in our school, we have enrolled all our students in 6th to 9th standards with Bharathidasan University Special Computer Education programme and our qualified computer teachers teach basics of computers, office automation, graphic design, web design, mobile app and web development in our well-equipped computer laboratory. We provide Computer Science and Computer application electives in 11th and 12th to around 300 students. In addition, for 100 students in 11th and 12th, who have not opted for computers as elective subjects, we still provide computer education as an additional subject.



Our school is now focused on providing high quality accountancy education in our higher secondary classes. In this regard, we are now providing concept based accountancy education to our students. This will enable them to do well in their current academics. Further, it will enable them to excel in their higher studies and also get suitable employment in the vast financial services sector in India. We are embarking on an ambitious program to help, with focused coaching, those interested students who may try to pursue professional Accountancy courses.



Students who have studied upto 5th standard in government/ government aided schools, which have only upto 5th grade, join our school in 6th standard. Their skills in reading and writing Tamil and English and in Mathematics is woefully inadequate. Further, in our state board education system, everyone gets promoted all the way upto 9th standard and they face real test in 10th Public examination.



There is a strong need for proper foundation in middle school (6th to 8th). We have recruited qualified teachers (since the government does not provide them) in Tamil and English to teach the languages to the middle school students. We provide them quality computer education with hands-on working with computers. There is extra coaching for the weak students and we provide support for them to complete their homework every day.



I am delighted to hear about the P.S.Higher Secondary School Alumni Meet on 15<sup>th</sup> October. Since I am abroad, I am not able to participate in the celebrations. I am proud to be a part of this great institution. As Alumni, we should endeavour to show our gratitude to the School. I am sure the Alumni Association will help in this regard. The years we spent in this school are the best part of my life.

### Current status and support required

P.S. Higher Secondary School, today, is a government aided school catering to the children coming from the lowest socio economic strata of the society. There are no tuition fees levied from the students. Except for provision of government teachers in most subjects, the government does not provide any grant or support for running the school. Even for normal running of the school, management has to depend on contributions from alumni, public and other well-wishers.

In order to ensure sustenance of the School in future, we have commenced the following three funds:

1. Middle School Special Education Fund ( to enable engaging teachers in critical subjects like Tamil, English, Mathematics and Computers)
2. Technology upgradation Fund (to enable provision of computers, smart panels and related teaching and other capital expenditure)
3. PSHSS Amenities Fund (to enable a healthy environment for learning by the students.

This includes properly maintained class rooms, laboratories, utilities, support for free noon meal facility and the different co-curricular and extra-curricular activities.

Contribution to the above funds are eligible CSR expenditure (Ministry of Corporate Affairs registration CSR 00027626). Donations are eligible for Tax deduction under Sec 80G of the Income Tax.
